#### 4984 Open Forum for discussion of any topic raised by residents

Eric Haykin spoke on behalf of the Neighbourhood Plan. -He stated that In relation to neighbourhood plan, 1 project is the flood alleviation plan. And he is working with BDC. He brought a flood alleviation plan for the members to look through and asked for feedback. He suggested an item on January agenda for discussion so that it can be taken forward or amended. He asked for any comments be sent to him. The plan will be scanned and sent to the members after the meeting.

ACTION: Clerk

John Rogers spoke on behalf of the Friends of Woodlands and Coachwood Green. – He presented a report having surveyed people around the village. He would like an item on the agenda in February to give updates regularly. He will contact the clerk to let the members know when he will attend. He stated that 700 people went through the footfall survey of which 65% support the project. They have applied for a grant and got HCA to prepare planning permission documents, with initial plans drawn upusing survey results they plan to put in pre planning application to BDC. A meeting in Jan to get plans put forward, therefore he cannot update the members until at least the February meeting. The survey will be scanned and sent to the members after the meeting. **ACTION: Clerk** 

It was also mentioned that the path from Rhodesia is now completed and Cllr Jones proposed that we check if we can claim the VAT back from this project before we do this with HMRC. Cllr Hunt seconded this.

Mike Wild spoke about the incinerator campaign. — He expected the application to arrive in July but nothing has happened. He asked that the incinerator group come to present their report to the Parish Council. They will contact clerk to ask nearer the meeting when an application appears. He asked if the Parish Council could help in promoting recycling in Shireoaks with perhaps some composting garden waste scheme. He stated that 95% of villagers are against the incinerator.

Min 4973 it was advised that the letter sent to the Chief Executive had been passed to D Armiger for answer. It was said that having written to various people within BDC without response on several occasions it was felt that the Parish Council does not have a voice.

The existing stones which were to be put back at the edge of the garden cannot be reused. It was asked if ClIr Fielding could get a grant to get a fence round the garden.

### To receive reports/information from County & District Councillors 4990

No District Councillors attended the meeting. It was asked that a letter be sent to Cllr Pressley and Cllr Rhodes asking if they intended to come to the Parish Council meetings at some point in the future. ACTION: Clerk



An email had been sent by Cllr Pressley asking if the Parish Council had any projects for 2015 to let him know so that he could enquire if any funding was available.

He was also holding a roving surgery on the 20th December around the Leeds Road area and if there were any specific problems could the members let him known. He stated that the site allocations process had been called in by the councils' cabinet and subject to call in of the decision they agreed to cease the current consultation and start a new consultation in 2015. This was because of a change in Government policy on planning issues.

Finally he asked if the Parish Council would consider putting on a Christmas do for the pensioners in the village in 2015 and that he would be willing to assist with this if agreed.

An email was sent by Cllr Fielding stating that consultation was taking place as regards the speed limit prior to the village on Shireoaks Road. It is proposed to reduce the speed limit to 40. She asked that if there were any issues, that the members let her know.

#### Co-option of new members 4991

Mark Long attended the meeting with a view to being co-opted as a new member of the Parish Councillor. This was proposed as accepted by Cllr Blagg and seconded by Cllr Jones. Notification is to be sent to BDC. ACTION: Clerk

#### War Memorial Renovation Update 4992

It was reported that Mr Grundy is going to get a piece of stone to replace the broken piece around the memorial. Lidsters will then come and finish the cleaning process.

The grant from BDC will not be paid until all work is finished. But an email is to be sent to Simon Britt to ask that the money is still available and set aside for this purpose as proposed. ACTION: Clerk

#### Village Memorial Clock 4993

The church clock has stopped chiming the hourly repeats. Time assured have been asked to come to look at the problem. Hopefully it is repairable. They also suggested that perhaps the yearly service should co-incide with one of the time changes. It seems that the changing back by 1 hour is causing the most problems. ACTION: Clerk

There is an issue with parking near school on Monks Way outside the car park. It is hoped that this problem will be solved with new entry to school but until then it was agreed to write a letter to the school, and also a letter to Notts police asking for investigation.

Building rubbish was reported as being dumped near Marina Drive. ACTION: Clerk

A problem was reported due to moles round winding wheels, but this was agreed to be left until the spring now.

It was agreed to send a letter to Notts highways about reinstating the grass verge and collecting the remnants of the pruned trees after installing the bus stops at the end of Coach Road. ACTION: Clerk

It was reported that 2 cars are parking on Shireoaks Common near the solid white lines approaching the level crossing. They are causing larger vehicles to cross these lines and at busy times when the crossing is down a problem is occurring with oncoming traffic. They are parked here all day, presumably using the train. It was agreed to inform Notts police. **ACTION: Clerk** 

A complaint had been received with regards to horses escaping from the field next to the church and pooping in the graveyard and in the allotments. They were causing damage and bad feeling amongst villagers whose relatives were buried in the churchyard, and amongst the allotment owners. A letter is to be sent to the church. <u>ACTION: Clerk</u>
