24/25 Apologies for Absence

Apologies were received from: Cllrs S Fielding, P Blagg and G Robinson and District Cllr Pressley No Apologies were received from: Cllr T Wilkes

25/25 Declaration of Interest and to identify any agenda items from which the press and public should be excluded due to the confidential nature of the business.

None were declared.

26/25 To approve the minutes of the meetings held on 11th February 2025

The Minutes of the Meeting held on the above date, copies of which had been circulated previously to members, were confirmed as a true record.

Proposed by Cllr C Dixon and seconded by Cllr Ayton and signed by the Chair.

27/25 Matters Arising

a) V E Day Anniversary 8th May 2025

An email had been received from Rhodesia Parish Council asking if they could join in with plans for both VE and VJ Day. This was agreed and an email will be sent to the clerk.
They have been advised of the Fish & Chip deal at Shireoaks Fish & Chip shop and that tea and coffee will be made available for free. This will be sourced by Cllr Hauxwell.
An invoice has been received for the hire of the hall.
Cllr Hauxwell is in discussions with Ted Woodiss around H&S.
There is no plan at present to purchase gifts for the schoolchildren.

b) V J Day Anniversary 15th August 2025 An event is planned for Saturday August 16th at Shireoaks Sports & Social Club. It is to be a picnic on the grass with maybe a bouncy castle for the children.

A quote had been received from Ambocare (first aid) for £225 for this event. Unfortunately, Cllr Hauxwell is not here to oversee this event. An email will be sent to Rhodesia PC to ask for volunteers.

c) Village Tidy Up

i) Repainting of Road markings at Church corner This item will be removed from the agenda.

ii) Shireoaks Common – trees at A57 end of Village
 A quote had been received to tidy up this area from SWH Ltd and this was agreed with no objections.

A quote had also been received for the replenishment of stones on the flowerbeds at the end of Woodside Road and for making good a hole on Shireoaks Common where a lamppost had been moved by Notts CC d) Fireworks update.

A quote for fireworks had been received with a couple of options. It was agreed to use the increased price to gain the same amount of fireworks as last year. A quote from Ambocare for first aid had been received for £355 for this event. Donuts, Giros, Pancakes BBQ have shown interest in the event. Rhodesia PC had sent £500 donation to this event. An event plan is needed for this event too, sooner rather than later.

28/25 New Business

- a) Pollard of trees around the Church/Village Hall
 Cil money expense is allowed for the Graveyard and around any war memorials. Therefore, it was agreed to go ahead with funding this project. Proposed by Cllr Hauxwell and Seconded by Cllr Dixon
- b) More Flowerpots for Shireoaks Common/Leeds Road Unfortunately, the manufacturer, who makes these is now out of business, however the supplier is looking for another and will advise if he is successful. Meanwhile a delivery lorry has squashed one of the barrels at the end of Leeds Road. It was agreed to purchase a new one to replace this as soon as possible.
- c) Bassetlaw Spring Clean 29.3 to 12.4

This was advertised in the Newsletter and people were asked to contact the clerk if they wanted to take part. This will be put on social media too. The top end of the village at A57 is particularly full of rubbish.

An email had been received from Friends of Woodland asking if we wanted to join with them. Our litter pick is advertised already and over a few weeks. We do not get a lot of support, but this enables people to do a few hours over the time rather than a set day.
